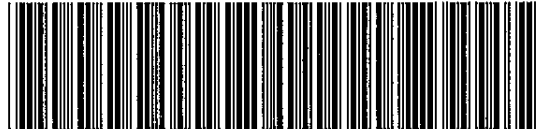


ARTICLE III

This limited liability company will be a member-managed company.


