

ARTICLES OF ORGANIZATION

OF

E. SCOTT NUNLEY, P.L.

The undersigned hereby certifies that the members have associated together for the purpose of becoming a professional limited liability company under Chapter 621 of the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of professional limited liability companies for profit. The undersigned further declares that the following Articles shall be the Charter and authority for the conduct of business of such professional limited liability company.
