ARTICLES OF ORGANIZATION OF MDC 5, LLC



A FLORIDA LIMITED LIABILITY COMPANY

- 1. Name. The name of the Limited Liability Company is MDC 5, LLC, a Florida limited liability company (the "Company").
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
- 3. <u>Purpose.</u> The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
- 4. <u>Place of Business.</u> The address of the Company's place of business in the State of Florida is 2070 South Orange Blossom Trail, Apopka, Florida 32703. The Company's mailing address is 2070 South Orange Blossom Trail, Apopka, Florida 32703.
- 5. Registered Agent and Office. The name of the initial registered agent of the Company is Kenneth L. Wood. The street address of the initial registered agent of the Company is 2070 South Orange Blossom Trail, Apopka, Florida 32703.
