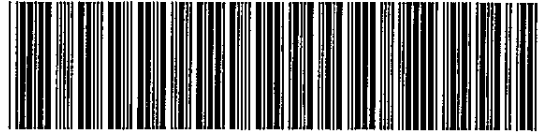



**ARTICLES OF ORGANIZATION FOR  
Oncology Care Consultants, LLC**

The undersigned individual is an organizer of a limited liability company formed under the Florida Limited Liability Company Act and hereby adopts the following Articles of Organization:

1. **Name.** The name of the limited liability company is Oncology Care Consultants, LLC.
2. **Duration.** The period of duration for this limited liability company is perpetual from the date of filing the Articles of Organization with the Secretary of State, unless dissolved by the members or as provided by state law.
3. **Purpose.** The purpose for which this limited liability company is organized is to perform any lawful purpose except that of banking and insurance.
4. **Principal Place of Business.** The street address of its principal place of business is

6. **Registered Agent & Office.** The name of the company's registered agent, whose Consent to Appointment as Registered Agent is included with these Articles, is Michelle M. Schirmer and the address of the registered office within this state 8114 Corky Lane, Jacksonville, FL 32244.
7. **Capitalization.** The total initial capital contribution by the members of this LLC has an agreed value of \$1,000.
8. **Additional Capital Contribution of Members.** Additional capital contributions shall be required upon such terms as are provided in the operating agreement.
9. **Admission of Additional Members.** Additional Members may be admitted to this LLC only upon such terms as are provided in the Operating Agreement.
10. **Continuation.** A majority of the remaining Members of the limited liability company may exercise the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued membership of a Member in this limited liability company, upon such terms as are provided in the Operating Agreement.
11. **Management.** The business of the company shall be conducted upon such terms as are provided in the operating agreement as adopted by its members, who shall vote according to the proportionate interest in their company and one or more managers appointed by operation of said agreement shall have exclusive authority to act for the company in all matters.
