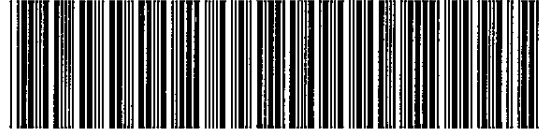

ARTICLE VIII-ADDITIONAL PROVISION


The power to adopt, alter, amend, repeal the regulations of the Company is vested entirely in the managing members listed in Article V.

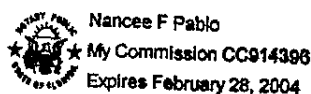
