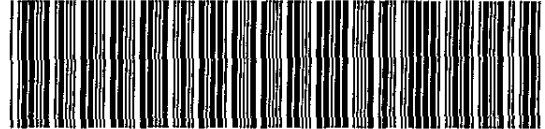



The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME. The name of the Limited Liability Company is *FINNEY PROPERTIES, LLC* (the "Company").

2. MAILING AND STREET ADDRESS OF PRINCIPAL OFFICE. The mailing and street address of the principal office of the Company is: 10960 Pine Creek Lane, Port St. Lucie, Florida 34986.

3. REGISTERED AGENT. The name and address of the initial registered agent in the State of Florida, whose Consent to Appointment as Registered Agent accompanies these Articles of Organization, are: Linnes Finney, Jr., 10960 Pine Creek Lane, Port St. Lucie, Florida 34986.

4. MANAGEMENT. The business of the limited liability company shall be managed by a manager and is, therefore, a manager-managed company. The name and address of the person who shall serve until a successor is elected and qualified is Twenty-Eighth Group Enterprises, Inc., 10960 Pine Creek Lane, Port St. Lucie, Florida 34986.

5. MEMBERSHIP RESTRICTIONS. Members shall have the right to admit new members by unanimous consent. Contributions of new members shall be determined as of the time of admission to the limited liability company.
