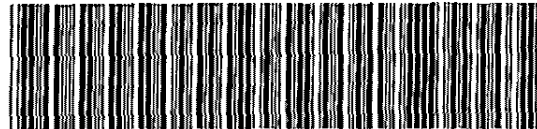



ARTICLE I

**Name**

The name of the limited liability company ("Company") is

## ARTICLE IX


### Effective Date


