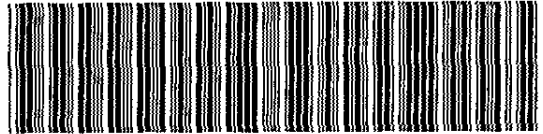


2. The primary business to be carried on by the company is to own and operate franchised restaurants at one or more locations.
