**ARTICLE I
NAME**

The name of the limited liability company shall be EVADAR, LLC ("Company").

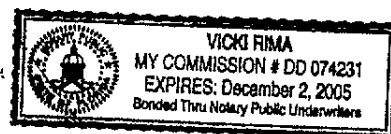
