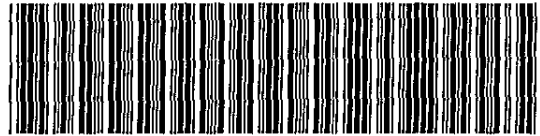


1. Article III of the Articles of Organization mistakenly described the purpose for which the Company is organized.

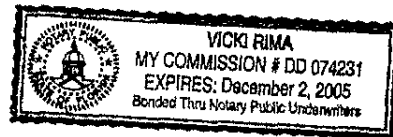
