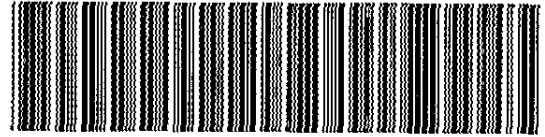

ARTICLES OF ORGANIZATION

of

“ARXEAN, LLC”

The undersigned, desiring to form a Limited Liability Company pursuant to the Florida Limited Liability Company Act (“Act”), does hereby make, acknowledge, and file the following Articles of Organization:

- I. **NAME.** The name of the limited liability company formed pursuant hereto shall be at all times **ARXEAN, LLC** (“Company”).
- II. **PURPOSE AND POWERS.** The Company shall be organized for the purpose of conducting any lawful business, and shall have the same powers as an individual to do all things necessary or convenient to carry out the Company’s purpose, business and affairs.

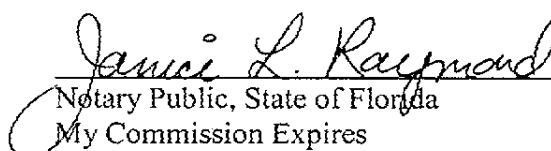

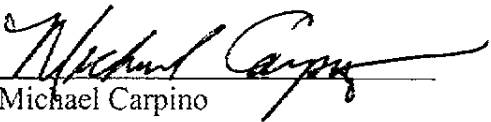
