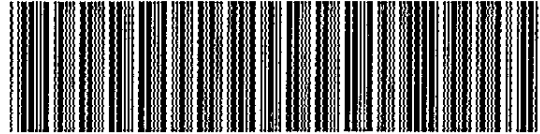

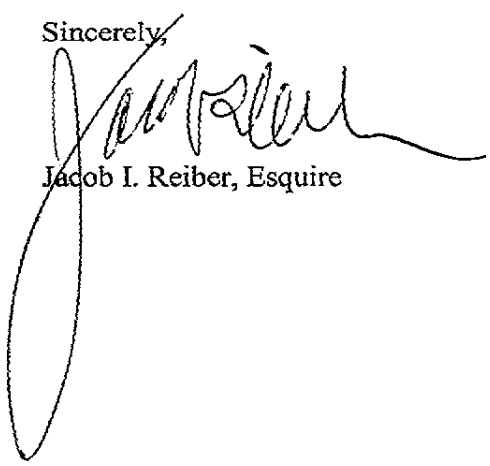

ARTICLES OF ORGANIZATION

OF

KOOL TEK, L.L.C.

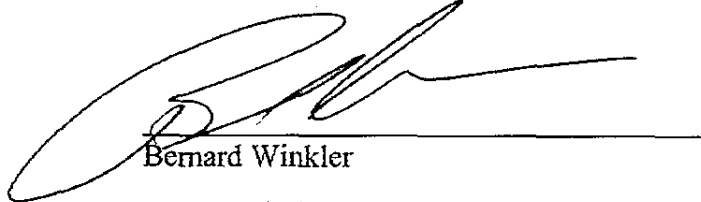
ARTICLE V

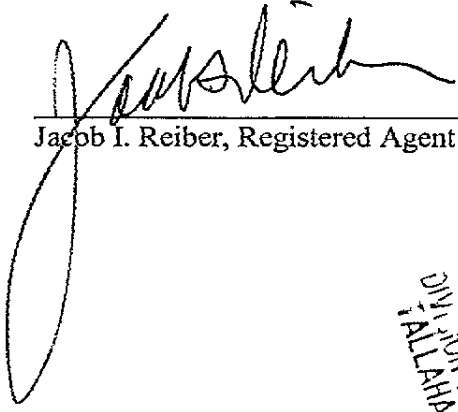
