# ARTICLES OF ORGANIZATION

OF

#### 9974 OLD BAYMEADOWS ROAD, LLC

The undersigned is a natural person competent to contract and hereby forms a Limited Liability Company under the Florida Limited Liability Company Act and other laws of the State of Florida.

# ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this Limited Liability Company is 9974 OLD BAYMEADOWS ROAD, LLC and its principal office is located at and its mailing address is 9974 Old Baymeadows Road, Jacksonville, Florida 32256.

#### ARTICLE II. DURATION

This Limited Liability Company shall exist for a period of thirty years.

To enter into, for the benefit of its employees, one or more of the following: (1) a pension plan, (2) a profit-sharing plan, (3) a compensation plan, or (4) other retirement or incentive compensation plan.

To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this Limited Liability Company enumerated in these Articles of Organization, or any amendment to it, necessary or incidental to the accomplishment or furtherance of the purposes or objects of this Limited Liability Company.

To have, in furtherance of the organization's purpose, all of the powers conferred upon Limited Liability Companies organized under the Florida Limited Liability Company Act subject to any limitations contained in these articles of organization.

#### ARTICLE V. MANAGEMENT

The Limited Liability Company is to be managed by the members in proportion to their contributions to the capital of the Limited Liability Company as adjusted from time to time to properly reflect any additional contributions or withdrawals by members.

# ARTICLE VI. ADMISSION OF ADDITIONAL MEMBERS

No person may be admitted as a member unless each member consents in writing to the admission of the additional member.

# ARTICLE VII. MEMBERS RIGHT TO CONTINUE BUSINESS

The remaining members of the Limited Liability Company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurance of any other event which terminates the continued membership of a member in the Limited Liability Company. Such right shall be exercised by the written consent of all remaining members within 90 days after the date of occurance of any event which terminates this Limited Liability Company.

# ARTICLE VIII. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Limited Liability Company is 9974 Old Baymeadows Road, Jacksonville, Florida 32256 and the name of the initial registered agent of this Limited Liability Company at that address is Stephen P. Connolly. The members shall have the power to establish branch offices, and to move the principal office to any other address in Florida.

#### ARTICLE IX. REGULATIONS

The members of this Limited Liability Company shall have the sole power to adopt, amend or repeal regulations for the management of this Limited Liability Company.

# ARTICLE X. AMENDMENT

These Articles of Organization may be amended in the manner provided by law.
