**ARTICLES OF ORGANIZATION  
OF  
HKZ ENTERPRISES, LLC**

**ARTICLE I  
NAME**

The name of this limited liability company is HKZ Enterprises, LLC, a Florida limited liability company (the "Company").

**ARTICLE II  
DURATION**

The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

**ARTICLE III  
PURPOSE**

**CERTIFICATED INTERESTS**


The members' interests in the Company shall be evidenced by certificates.
