The name of the limited liability company (hereinafter referred to as the "Company") is The Right Side Stable, LLC.

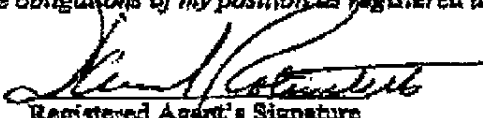
ARTICLE II — Address:

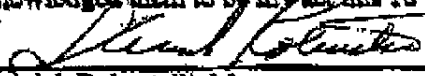
