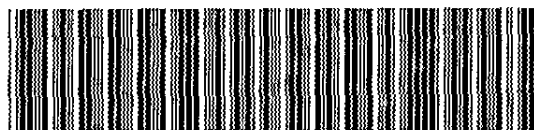

The limited liability company shall not be required to be a member-managed company.

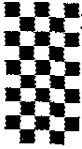
