ARTICLES OF ORGANIZATION OF 1 PLUMBING CO. , L.L.C

ARTICLE I

Name

The name of the limited liability company ("Company") is 1 PLUMBING CO., L.L.C.

<u>ARTICLE II</u>

Address

The mailing address of the Company's principal office is 6847 Middleton Avenue, St. Augustine, Florida 32080

ARTICLE III

Registered Agent and Office
