ARTICLES OF ORGANIZATION OF PWP, LLC, A LIMITED LIABILITY COMPANY

The undersigned certify that we have associated curselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be PWP, LLC, and its principal office shall be located at 20702 West Pennsylvania Avenue in the City of Dunnellon, 34431, County of Marion, State of Florida, but it shall have the power and authority to establish branch offices at a within or outside of the State of Florida as the members may designate.

ARTICLE II

PURPOSES AND POWERS

In addition to the powers authorized by the laws of the State of Florida Companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be as follows:

- 5. To exercise all or any of the limited liability company powers, and to carry out all or any of the purposes, enumerated in these Articles and otherwise granted or permitted by large white action as agent, nominee, or attorney- in-fact for any persons or corporations, and perform any service under contract or otherwise for any corporation, joint stock company, association, partnership, firm, syndicate, individual, or other entity, and in this capacity or under this arrangement develop, improve, stabilize, strengthen, or extend the property and commercial interest of the property and to aid, assist, or participate in any lawful enterprise in connection with or incidental to the agency, representation, or service, and to render any other service or assistance it may lawfully do under the laws of the State of

Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

6. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the accomplishment of any of the objects, or the furtherance of any of the accomplishment of any of the objects, or the furtherance of any of the name of the name of the same shall not be inconsistent with the laws of the State of Florida.

EXERCISE OF POWERS

MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members, upon terms and conditions to be agreed by the unanimous consent of all of the then members. Contributions required of non-conditions determined as of the time of admission to the limited liability company.
