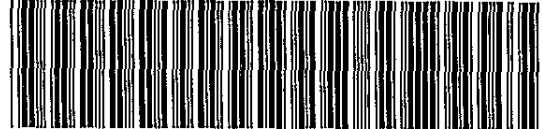

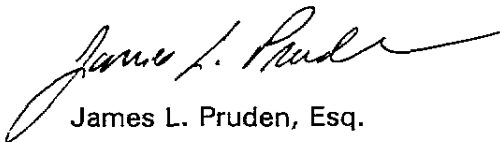

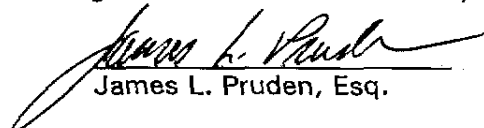

#### ARTICLE VI – MANAGEMENT

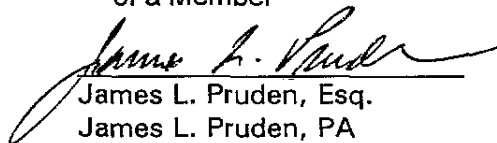
