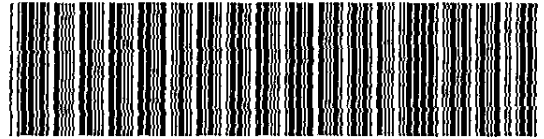

ARTICLE IV – DURATION

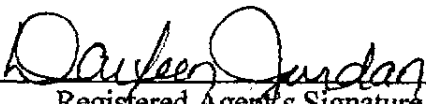
