4. Except as expressly modified hereby, the terms, provisions and contents of the original Articles of Organization shall remain in full force and effect without waiver, modification or correction hereby.

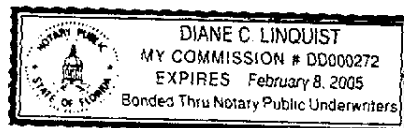

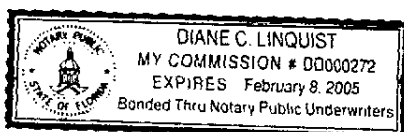
