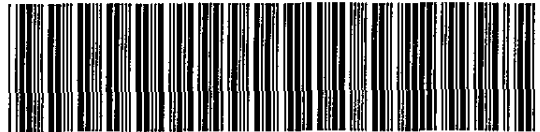


Article VI
