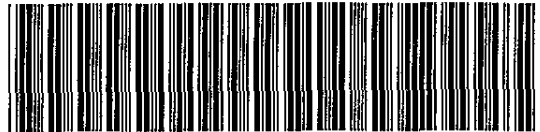


Article VI


