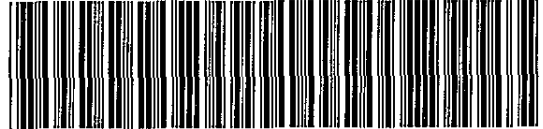

Articles of Organization**


This company is formed under the *Florida Limited Liability Company Act*, Chapter 608 of the *Florida Statutes* by filing these articles of organization with the Department of State.

1. **Name.** The name of this company is BLK of Jacksonville, LLC.
2. **Initial Principal Office.** The street address for the initial principal office is 4003 Old San Pablo Road South, Jacksonville, Florida 32224. The mailing address of this company c/o Ryan and Marks Attorneys, LLP, 3000-8 Hartley Road, Jacksonville, Florida 32257.
3. **Initial Registered Office and Agent.** The street address of the initial registered office for service of process is 3000-8 Hartley Road, Jacksonville, Florida 32217. The initial registered agent at that office is William B. Ryan, Jr. That initial registered agent has signed at the end of these articles to make his statement of acceptance required by Section 608.415 of the Act.
4. **Manager-managed.** This company will be manager-managed unless otherwise agreed in the operating agreement. The initial manager, who is also the only member, is Barry Kryspin. His address is 4003 Old San Pablo Road South, Jacksonville, Florida 32224.
5. **Effective Date.** These articles are effective upon acceptance for filing by the Department of State.
6. **Other Terms.** All other terms for the organization and management of this company will be found in writing only within the operating agreement, as it may be properly amended from time to time.
7. **Authorized Representative.** The authorized representative signing and filing these articles is the only member. He is the manager and his name and address are shown in Section 4.
