

This company is formed under the *Florida Limited Liability Company Act*, Chapter 608 of the *Florida Statutes* by filing these articles of organization with the Department of State.

- 1. **Name.** The name of this company is BLK of Jacksonville, LLC.
- 2. **Initial Principal Office.** The street address for the initial principal office is 4003 Old San Pablo Road South, Jacksonville, Florida 32224. The mailing address of this company c/o Ryan and Marks Attorneys, LLP, 3000-8 Hartley Road, Jacksonville, Florida 32257.
- 3. **Initial Registered Office and Agent.** The street address of the initial registered office for service of process is 3000-8 Hartley Road, Jacksonville, Florida 32217. - 5. **Effective Date.** These articles are effective upon acceptance for filing by the Department of State.

- 7. **Authorized Representative.** The authorized representative signing and filing these articles is the only member. He is the manager and his name and address are shown in Section 4.
