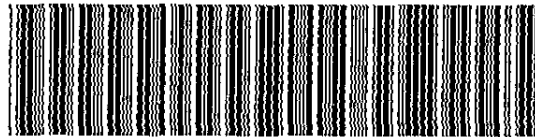

ARTICLES OF ORGANIZATION

The undersigned hereby certify that they have associated themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of this limited liability company is LAWSTER ENTERPRISES, LLC, and its principal office and mailing address is located at 112 Greenbriar Road, Palatka, FL 32177-8877.

ARTICLE II - DURATION

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

ARTICLE III - PURPOSE

The purpose of this limited liability company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL CONTRIBUTIONS

The total amount of cash, property and non-cash contributions contributed to this limited liability company by its members upon the filing of these Articles of Organization is Thirty Thousand and No/100 Dollars (\$30,000.00). The members are free to agree upon additional contributions to this limited liability company at any point in the future.

ARTICLE V - MEMBERSHIP

The members of this limited liability company have the right to admit additional members to this organization upon the unanimous consent of those individuals or entities that are members prior to the admission of the new member. However, the transferee or assignee shall not be entitled to become a member or participate in the business and affairs of this limited liability company unless the transfer or assignment is approved by the unanimous consent of the members not proposing to transfer or assign their interests.

ARTICLE VI - DISSOLUTION

The limited liability company will dissolve as provided in the Operating Agreement executed by and among the members.

ARTICLE VII - MANAGEMENT

This organization is to be managed by a general manager and a business manager elected by a majority vote of its members. The initial general manager, who shall serve until the earlier of his death, resignation, replacement or until the first annual meeting of members and successors are elected and qualified, shall be:

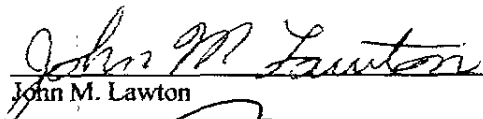
ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT
