The mailing address and street address of the principal office of the Company is 1655 The Greens Way #1111, Jacksonville Beach, Florida 32250.

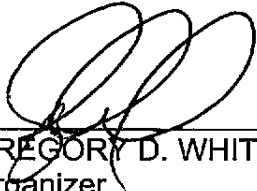
**ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS**

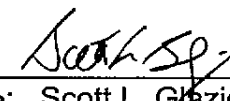
