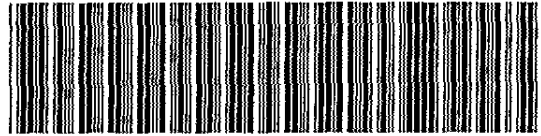




### ARTICLE X - Regulations
