

#### ARTICLES OF ORGANIZATION

## WENDELL INGALLS, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE L NAME

The name of the Limited Liability Company shall be Wendell Ingalls, LLC ("Company").

#### ARTICLE II. ADDRESS

The physical street address of the principal office of the Limited Liability Company 151 North Otter Creek Avenue, Otter Creek, Florida 32683, and the mailing address is P.O. Box 107, Otter Creek, Florida 32683-0107.

### ARTICLE III. DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement of the Company.

#### ARTICLE IV. CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/OFFICE
