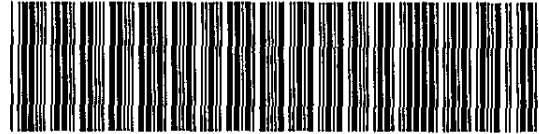



SECOND: The following Amendments to the Articles of Organization were adopted by the Limited Liability Company;


ARTICLE IX shall hereafter read as follows:


IT IS AGREED AS FOLLOWS:
