


## ARTICLES OF ORGANIZATION

### AAS MANAGEMENT, LLC

The following shall constitute the Articles of Organization for **AAS MANAGEMENT, LLC**, a limited liability company (the "Company"):

- I. **Name:** The name of the Limited Liability Company is AAS MANAGEMENT, LLC.
- II. **Management:** The Company shall be managed by a manager or Managers, as may be more particularly provided by the Members in the Operating Agreement.
