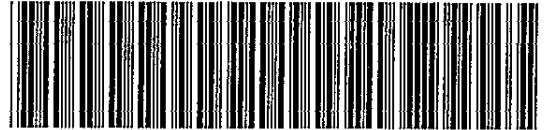


ARTICLES OF ORGANIZATION

AAS I, LLC

The following shall constitute the Articles of Organization for **AAS I, LLC**, a limited liability company (the "Company"):

- I. **Name:** The name of the Limited Liability Company is AAS I, LLC.
- II. **Management:** The Company shall be managed by a manager or Managers, as may be more particularly provided by the Members in the Operating Agreement.
- III. **Address:** The mailing address of the Company is 2435 Colinas Corte, El Cajon, CA 92019. The street address of the principal office of the Company is 10500 Winborough Drive, Port Charlotte, FL 33981.

- V. **Operating Agreement:** The Company shall be operated in accordance with the provisions of the Operating Agreement which shall be entered by the Members. The Operating Agreement shall govern the admission of new members of the Company, assignability of ownership interests in the Company, termination and dissolution of the Company, distributions, the obligations and rights of the members and any other matters which the Members shall provide therein.
