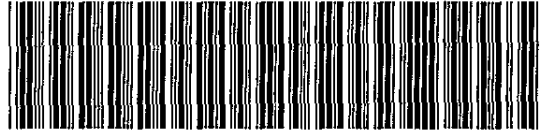

The name of this Limited Liability Company is Jim Cobb, LLC

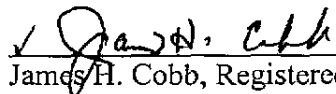
ARTICLE II--ADDRESS
