#### ARTICLES OF ORGANIZATION

#### FOR

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I NAME

The name of this Limited Liability Company shall be JAMO SERVICES, L.L.C. (hereinafter "L.L.C.").

# ARTICLE II ADDRESS

The mailing address and street address of the principal office of the L.L.C. is 150 E. Hillcrest Street, Altamonte Springs, Florida, 32701.

## ARTICLE III DURATION

The L.L.C. shall commence its existence on the date these Articles Of Organization are filed by the Florida Department of State. The L.L.C.'s existence shall be perpetual unless the L.L.C. is dissolved earlier as provided in these Articles Of Organization or in the regulations.

## ARTICLE IV REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the L.L.C. in the state of Florida are JAMES E. OUELLETTE, 150 E. Hillcrest Street, Altamonte Springs, Florida, 32701. The L.L.C. may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.

## ARTICLE Y ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the L.L.C. except with the unanimous written consent of all the members of the L.L.C. and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the L.L.C. as set forth in the regulations of the L.L.C., but the transferee shall have no right to

participate in the management of the business and affairs of the L.L.C. or become a member unless 100% of the members of the L.L.C. other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

#### ARTICLE VI MEMBERS' RIGHT TO CONTINUE BUSINESS

The L.L.C. shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the L.L.C., unless the business of the L.L.C. is continued by unanimous vote of the remaining members.
