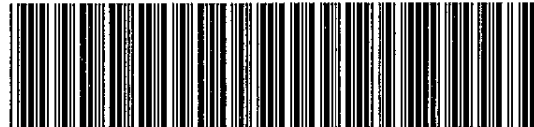

The undersigned hereby files these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I
Name and Address

The name of this limited liability company shall be **JESSIE TUDOR CARPENTRY, LLC**. The address of its initial principal office is 1505 Dove Road, Tallahassee, Florida 32317, and its initial mailing address is the same. The office address and mailing address may be changed from time to time at the discretion of this limited liability company, or as otherwise provided by Florida law.

ARTICLE II
Term of Existence

This limited liability company shall exist perpetually unless dissolved according to law and shall commence upon the filing of these Articles of Organization by the Department of State of the State of Florida.

ARTICLE III


