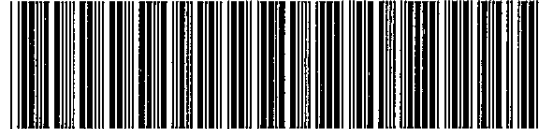


ARTICLE III


