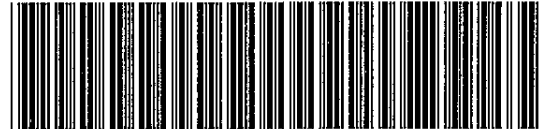



ARTICLE I - NAME


ARTICLE IV -- CAPITAL CONTRIBUTIONS

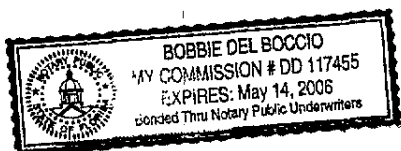
