The name of the Limited Liability Company is JG FAMILY HOLDINGS LLC.

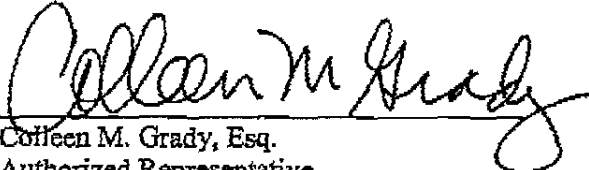

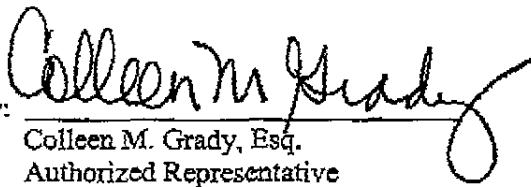

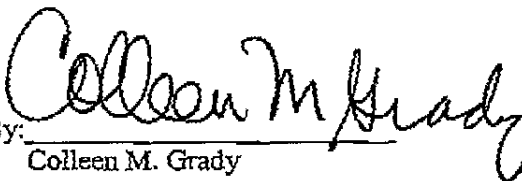
