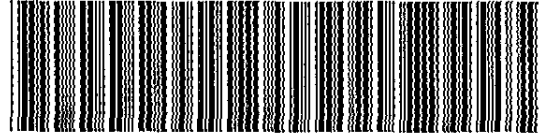

NAME

ARTICLE II

COMMENCEMENT OF COMPANY EXISTENCE
