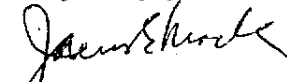

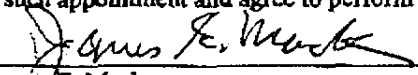
THE ARTICLES OF ORGANIZATION OF GEORGE MAHAN CERAMIC TILE, L.L.C.

1. The Members of George Mahan Ceramic Tile, L.L.C. (the "Company"), a limited liability, company, created under the Florida Limited Liability Company Act, (the "Act") do hereby enter into this Operating Agreement in order to regulate the affairs, conduct the business and establish the relations of its members; and for these purposes do hereby mutually agree as follows:
2. **Formation of Limited Liability Company:** The Members have formed the Limited Liability Company by the filing of Articles of Organization (the "Articles") with the Florida Secretary of State. The Company's business is conducted under the name George Mahan Ceramic Tile, L.L.C. until such time all the Members designate otherwise and file amendments to the Articles in Accordance with applicable law.
3. This Operating Agreement is subject to, and governed by, the Act and the Articles. In the event of a direct conflict between the provisions of the Operating Agreement and the mandatory, provisions of the Act or the provisions of the Articles, such provisions of the Act or the Articles are controlling.
4. **Names, Address, and Initial Capital Contributions of Members.** George Mahan, 2317 Silver Palm Drive, Edgewater, FL 32141. Phone number: 386/427-7110.
5. **Principal Office/Mailing address:** 2317 Silver Palm Drive, Edgewater, FL 32141
6. **Admission of Additional Members.** As provided in the Articles, the Members may admit to the Company additional Members (s) to participate in the profits, losses, available cash flow, and ownership of the assets of the Company on such terms as are determined by all of the Members, admission of any such Additional Members requires the written consent of all Members then having any Interest in the Company, and any Additional Members are allocated gain, loss, income or expense by the method provided in the Operating Agreement, and if now method is specified, then as may be permitted by Section 706(d) of the Code.
7. The purpose of George Mahan Ceramic Tile, L.L.C. is for any lawful purpose, to include the buying and selling of goods, services, securities and real estate. To accomplish that purpose, the company shall have the right to enter into contractual arrangements, to lend and borrow money and initiate all business procedures relating to the buying and selling of goods, services, securities and real estate.
8. The Company will be an owner-managed company by George Mahan.
9. The Company will be chartered for 5 years with a 5 year option.
10. Allocation of Profits shall be by charter member and manager, George Mahan, in his sole and absolute discretion.
11. There will be no company voting nor company meetings set on a regular schedule.
12. The company, will work and set its books on a calendar year ending December 31, 2003.
13. Termination of the LLC shall be by election, choice, death, or bankruptcy.
14. The initial registered agent shall be James E. Mack, 1321 Saxon Drive, New Smyrna Beach, FL 32169
