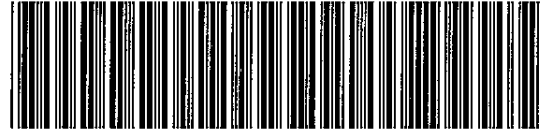

Additional members may be admitted upon the transfer of all, or any portion of, a member's interest or rights in the manner set forth in the Operating Agreement of the Company.


ARTICLE VII - Registered Agent and Office:


