ARTICLE V — Management:

The Limited Liability Company is to be managed by one or more Managers and is therefore a Manager Managed Company. The Members may appoint successor Managers as permitted in the Operating Agreement. The initial Managers shall be Christopher G. Cogan and Curtiss E. Cogan. Subject to any limitations imposed in the Operating Agreement, the Managers may act independently of each other and any person dealing with a Manager may rely on the authority of such Manager to act independently except with actual notice to the contrary.
