



## a Florida Professional Limited Liability Company

The undersigned individual, being the authorized representative of a member, hereby presents these Articles of Organization to the Secretary of State of the State of Florida for the formation of a Professional Limited Liability Company under the laws of the State of Florida in general and Chapters 608 and 621 of the Florida Statutes in particular.

# ARTICLE I NAME

The name of this Professional Limited Liability Company is: DELGADO & FLEITES, M.D., P.L.

# ARTICLE II NATURE OF BUSINESS-PERFORMANCE OF MEDIÇAL SERVICES

- A. The general nature of the business to be transacted by this professional limited liability company is to engage in the practice of Medicine and in every other activity in which a professional limited liability company organized under the laws of the State of Florida may lawfully engage.
- B. All professional services of Medicine shall be rendered only through those of the members, officers, employees and agents of the professional limited liability company who are duly licensed or otherwise legally authorized to render such professional services within the State of Florida.
- C. No member of this professional limited liability company may sell or transfer any ownership interest in this professional limited liability company except to a professional corporation, individual or other professional limited liability company eligible to be a member of this professional limited liability company.

# ARTICLE III ELIGIBLE MEMBERS

- A. Only individuals, professional corporations and other professional limited liability companies who are duly licensed and otherwise authorized to practice Medicine under the laws of the State of Florida may be officers, members or managers of this professional limited liability company.
- B. No member of this professional limited liability company may enter into any type of agreement vesting another person with the authority to exercise any of the member's voting power in this professional limited liability company.

## ARTICLE IV TERM

- A. This professional limited liability company is to exist in perpetuity.
- B. The existence of this professional limited liability company shall commence on the date these Articles are filed with the Secretary of State of the State of Florida.
