These Amended Articles of Organization have been filed and executed in accordance with Florida Statutes Section 608.411 and meet all of the requirements set forth in Florida Statutes Section 608.407.

This Amended Articles of Organization is submitted to amend the Articles of Organization as follows:

ARTICLE I

NAME
