**ARTICLE 3
DATE OF APPROVAL OF DISSOLUTION**

The Member Managers of the Company held a regular meeting of the Member Managers on June 2, 2017 at which a quorum was present. At the meeting it was determined that it was in the best interests of the Company to dissolve and for the assets of the Company be liquidated in accordance with the Plan of Dissolution presented and approved by the Member Managers at the meeting. Under the Plan of Dissolution which conforms to the relevant provisions of the Operating Agreement, the net assets of the Company after the collection and allocation income and the payment of creditors shall be distributed to the Member Managers during the winding up period. No continuing operations of the Company will occur following the Effective Date, defined below.

The Dissolution of the Company was approved on June 2, 2017 by Four (4) of the Five (5) Member Managers which was sufficient for passage of the Articles of Dissolution and Plan of Dissolution under the terms of the Operating Agreement.

The effective date for the Dissolution is June 2, 2017 ("Effective Date").

The Company has no liabilities other than liabilities incurred in the ordinary course of business as of the approval date and no liabilities will be incurred prior to the Effective Date. There are no suits pending against the Company in any court.
