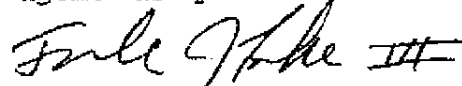
1. Name. The name of the limited liability company (hereinafter "company") is LAKE FAMILY, LLC.
