

## ARTICLES OF ORGANIZATION OF CANDLER & GONSALVES, L.L.C.

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

We further declare that the following Articles will serve as the Charter and authority for the conduct of business of the limited liability company.

## ARTICLE I Name and Principal Place of Business

The name of the limited liability company shall be CANDLER & GONSALVES, L.L.C., and its mailing address and principal office shall be located at 412 Azalea Street, Panama City Beach, Florida, 32407, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

## ARTICLE II Purposes and Power

To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objectives, or the furtherance of any of the powers set forth in these Articles, either alone or in association with others incidental or pertaining to, or going out

of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.

#### ARTICLE III Exercise of Powers

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of the members of this limited liability company. This Article may be amended from time to time and the regulations of this limited liability company by majority vote of the members of the limited liability company.

### ARTICLE IV Management
