1. Name. The name of the limited liability company is TONERTYPE OF FLORIDA, LLC (the "Company").

2. Articles of Organization. The date of filing of the Articles of Organization of the Company was December 1, 2003 (Document Number L03000048761).

3. Amendment. The Articles of Organization of the Company are hereby amended as follows:

Article 1 is deleted and a new Article 1 is inserted in lieu thereof, to read as follows:
