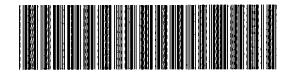

- 1. Name. The name of the limited liability company is TONERTYPE OF FLORIDA, LLC (the "Company").
- 2. <u>Articles of Organization</u>. The date of filing of the Articles of Organization of the Company was December 1, 2003 (Document Number L03000048761).
