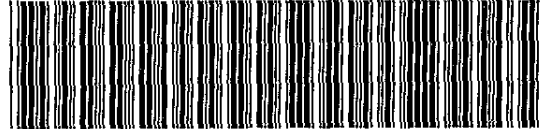

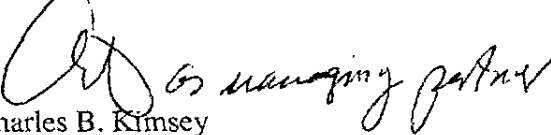

OF
